THE CHAIRS REPORT

In December 2022, I was elected as the Chair of Ngā Tokorima a Hinemanuhiri and excited to accept the role and committed to the roles and responsibilities that entailed. The role itself is a daunting one along with the deep sense of responsibility I feel to serve our whānau, marae and hapū of the rohe and do a good job.

As, we sit today at the Annual General Meeting for Ngā Tokorima a Hinemanuhiri 2023, in April of 2024, after the devastating impacts from Cyclone Gabrielle ripped through the community on February 14th 2023, I note that during this period December 2022 to June 2023 for which this report is written was in response to that cyclone; a reminder that it was a time of trauma, grief and loss. The impacts of Cyclone Gabrielle ripple throughout our community still today and we must always be mindful that recovery for the majority hugely impacted it is far from over. In fact, with our community still under 2A category the journey has barely started.

My role over the past year as the Wairoa Recovery Manager gave me insights and first-hand knowledge of the disappointment, frustration, lack of resource, housing pressure homelessness and the suffering of those who have lost everything.

During that time, there were many times we saw compassion, aroha, strength, grit and massive amounts of generosity, saw whānau pull together, our marae and hapū members in all ways respond to support each other, and that was incredible.



NTAH Trust Operations

On assuming the role of Chair, one of the objectives was to streamline administrative costs and optimise Trust operations. We did look into bringing on an administrator to continue the work, and then when the cyclone hit everything changed.

Consequently, the decision to halt the contracting of an administrator was made, with Trustees committing to undertake the necessary tasks to maintain the Trust's functionality and fulfill its obligations. Currently we have a part-time administrator and looking to bring on board a small operational team.



Chairs Report Continue...

The approach to halt administration proved effective initially, with the emergence of new demands, including the response and recovery from the cyclone, where the majority of the directors of the Trust were impacted directly or indirectly. In addition to there is the management of all the DSP transfers, establishment of Joint Ventures (JVs), and daily operational requirements, necessitated a reconsideration of our operational strategy. It became evident that this approach was not sustainable. In order to drive forward we needed a strong Ngā Tokorima a Hinemanuhiri (NTAH) standing forward, it is imperative to reassess our operational structure and roles to ensure the effective functioning of NTAH. This seeks to better align the work of the Trustees to lead various Ohu, enhance governance effectiveness, and strengthen the Trust's position for sustainable growth and impact.

NTAH Charitable Trust Update

As per the resolution passed during the Annual General Meeting (AGM) in December 2022, the establishment of the Charitable Trust was postponed. However, I am pleased to inform you that Mihiarangi Piripi, from Kāhui Legal, is currently facilitating this process in collaboration with the Trust. Upon the establishment of the Charitable Trust, it will pave the way for engaging in contractual agreements to execute projects outlined in the strategic plan. This approach will help offset operational costs associated with the project delivery.

Deferred Selection Properties (DSPs) Update.

After a protracted and intricate process, the Deferred Selection Properties (DSP) transfer has demanded much time and effort. The journey has been marked by fluctuating timelines and evolving information from various government agencies, compounding the pressure already felt within our community. NTAH, in collaboration with the support of Tātau Tātau o Te Wairoa, has made notable strides in advancing the Deferred Selection Properties (DSPs) initiative. Specifically, progress is being made with respect to the DSPs associated with our NTAH Joint Ventures (JVs), namely Whare/Kura JV Ltd and Turiroa JV Ltd. Currently, these properties are under the custody of Tātau Tātau o Te Wairoa Trust (TToTW), as outlined in the TToTW Trust Deed Settlement. The scheduled transfer of these properties to the Joint Ventures is scheduled for June 2024.

Turiroa JV

The Turiroa Joint Venture (JV) Company is made up of 6 directors, two from each of the Kāhui. Significant work has been undertaken to complete legalities and set up of the JV completed in tight timeframes so that the property can be officially handed over to the JV in June 2024.

Progress Update

Tātau Tātau o Te Wairoa was successful in \$1 million grant to support the development of the Turiroa property from the Ministry of Business, Innovation and Employment (MBIE) for the development of Turiroa School into temporary accommodation for trades needed for the Wairoa rebuild as part of the Cyclone Gabrielle recovery. The facility will provide accommodation for up to 19 trades people needed for the rebuild and the work across the rohe on the massive roading work that needs to be done over the next 5-7 years. The Turiroa JV has been meeting weekly for the past 4 months to work through all aspects of the JV set up, the working relationship with TToTW the contract holders, and the development of the property. The development has gone to tender, and the successful tender will be announced in due time.

Whare/Kura JV

This JV includes North Clyde School, 27-31 Scott Street Properties, and the Kaimoana Road, corner of Kaimoana road & Airport Road) section, EIT and Mackley Street and is made up of 6 directors from the three following Kāhui.

Progress Update

The JV set up is close to completion and when ready the properties will transfer to them from TToTW. North Clyde and Mackley Street transferred to TToTW on March 28 th . TToTW is in negotiations with Waka Kotahi about potential development of North Clyde School. EIT still sites with LINZ until transferred to TToTW, work continues to progress this until it moves from TToTW to the JV in June 2024.

The Whare/Kura JV is now scheduled to meet fortnightly to progress this.

Awamate Huramua DSP

The following are the JV directors for the Awamate property. There are issues with this property returning as this is under a perpetual lease. Lawyers have investigated this and have said it is watertight lease, meaning there is not much we can do about it. Further work is needed and a meeting with the lease holders is a possibility.

What is a perpetual lease?

A perpetual lease is a lease that has no end. Perpetual leases were introduced because settlers wanted guarantees that these would be renewed for as long as they wanted to remain on the land, so the Government introduced perpetually renewed leases. Perpetual leases were one of the many ways we as Māori were alienated from our lands.

Ruapapa/Ardkeen

Progress Update

This is solely a NTAH DSP. A feasibility report is being conducted to assess what options are available for the use of this property by Alan Wilcox.

NTAH & Pan Pac Forest Products

NTAH Trustee were approached from Pan Pac Forest Products Ltd representatives in late 2022, inviting engagement in an inclusive process concerning the proposed harvesting of their block at Titiranga maunga. It was crucial for us to ensure that our voice, along with our obligations and responsibilities as Kaitiaki, were incorporated into any planning and operational activities. Our priority was to ensure that Pan Pac Forest Products Ltd was respectful to and honoured the sacred sites of our ancestors and that all operations have planning in place to protect known sites and any other sites that are discovered during this process. There were two opportunities to meet on the maunga and a shared karakia was conducted prior to any of the work started. The archaeological report submitted by Dr. Gaylene Carter is available for your perusal. To oversee compliance with necessary obligations, Dr. Gaylene Carter of Archaeology Hawkes Bay was appointed as the independent archaeologist during this process.

A note to Ngā Tokorima a Hinemanuhiri Trustees

As an elected member of Ngā Tokorima a Hinemanuhiri we are responsible to all members of NTAH. We were elected to the position by our marae but I stress that as Trustees it is our duty to act for the benefit of all NTAH members.

Kanohi Kitea – NTAH Trust Office

NTAH are in discussion with Wairoa District Council to secure a lease for the Frasertown Post Office as an office space to operate from in our rohe. This is greatly increasing the Trusts presence and availability to our whānau and members.

TToTW Trust Director

Me mihi ka tika ki a Ira Heyder. This is a commendation to Ira Heyder for his diligent efforts and contributions. I would like to take this opportunity to acknowledge Ira's outstanding work as our Ngā Tokorima a Hinemanuhiri (NTAH) representative to the Tātau Tātau o Te Wairoa Trust as our representative. Ira has shown exceptional commitment in keeping NTAH Trustees abreast of the multifaceted operations and developments within TToTW and is in constant communication with me as the Chair of NTAH. Ngā mihi nui e te whanaunga.

Moving Forward

As I lead our Trust through the season of my term, I will with your support drive a proactive campaign to prioritise the work in the NTAH strategic plan to seek the return of any Crown owned land and assets set up an operational structure that will support the work of the Trust. The period for which this report is submitted was a demanding time for our whānau and community. We are not alone in our efforts to reconcile the timing of the AGM and I look forward to reporting on further developments for the 2024 Annual General Meeting. As the Chair of Ngā Tokorima a Hinemanuhiri I welcome any feedback and questions about this report, and if necessary, we will pass them over to General Business for further discussion. I runga i te taonga nui i waihotia mai e ngā tipuna te aroha. I ask that my report be accepted and supported by the whānau and members of Ngā Tokorma a Hinemanuhiri.

Papakainga Housing Project

The Papakainga Housing Project is administered by Te Puni Kokiri to address the housing needs of our people on Whenua Māori. Whenua Māori has been classified as:

Māori Freehold Land registered in the Māori Land Court as a Māori Title, OR Land in General Title where it once was Maori Title (pre the compulsory conversion to General Title from 1967 for example), OR Land in the process or intention of being converted back into Māori title OR Land that is considered to be Māori "customary" land with clear and demonstrated tikanga, history or other matters of significance (for example adjacent to a marae) meaning it is "attached" to the ownership and kaitiaki of the whānau/ hapū.

In the 2023/2024 Budget, the Labour Government added a further \$50 million to the Papakainga and healthy homes, totalling more than \$380 million across the country. I'm unaware what the commitment will be if the Government changes to National.

Te Puni Kokiri have published a guide to Papakainga Housing, Papakainga Project Planning & Feasibility Checklist which are attached.

My experience over the past 15 years having delved into this Kaupapa has been exhaustive, complex and daunting. Despite that though, with the political and environmental climate and housing crisis today, the benefits of this programme, if you persevere will (I'm sure) reap you positive and life changing rewards. So kia kaha whānau.

It's important you follow the three stage, six step process. For quick reference, most of this is on pages 3, 4, 7, 10, 13, 16, 19 and 24 of the guide. It is also worthwhile having a chat to a few people who have completed the processes as has been highlighted in the case studies.

The Wairoa region is captured in the Ikaroa-Rawhiti Gisborne office of Te Puni Kokiri, therefore you will need to register your interest there. Papakainga Housing Project continue...

STAGE 1

Stage 1 can take up to 2 Years depending on your situation (Ref to page 3 of the Papakainga Housing Guide). It includes:

Step 1: Whānau Planning - Up to 12 months (pages 4, 5, 6)

Step 2: Workshops/ Research - Up to 6 months (pages 7, 8, 9)

Step 3: Project Feasibility - Up to 6 months (pages 10, 11, 12). At this Step, and based on the information and research you have gathered from Steps 1 & 2, you can then apply for a Feasibility Grant. A typical grant is about \$90,000 per rūpu). The Fund is contestable, so it pays to make sure your application is tight. Follow the Papakainga Project Planning & Feasibility Checklist attached. This is focused on:

i. Whānau - pages 1 & 2, covering points 1, 2, 3 and 4 ii. Whenua - pages 2, 3, 4 & 5, covering points 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22

Whare - pages 6, 7 & 8, covering 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36 and 37

Step 4: Due Diligence - Up to 2 to 3 months (pages 13, 14, 15). At this Step, you will then be able to apply to Te Puni Kokiri for the Infrastructure Fund (approximately \$80,000 to \$100,000 per home, depending on the level of infrastructure needed). This will cover costs such as roading, power cables from the main road to the papakainga homes, waste water, sewerage and potable water system. During this stage, you should also be working on lodging your next funding application for the Construction of the homes. This Fund is approximately \$500,000 per home up to \$3 million per ropu, based on the 2022/2023 Budget.

STAGE 2

Step 5: Building/ Project Management - Up to 12 to 18 months (pages 16, 17, 18)

STAGE 3

Step 6: Housing Operations - Final stage / Completion of the Build which will set you up for the next 25 years of housing management (pages 19, 20, 21, 22, 23).

COMPLETED PAPAKAINGA IN NGĀTI KAHUNGUNU

In Ngāti Pahauwera - Mohaka/ Raupunga there is one Papakainga. Theresa Thornton managed this to completion. In Heretaunga there are: Te Aorangi Māori Trust Board Bennett Road, Waipatu; two in Kohupatiki, the Puna Whānau and the Robin Whānau; Waiohiki; Pukeaute based in Te Hauke managed by Zac Makoare and Waimarama Marae. Ngahiwi Tomoana is currently in the process of developing his whenua for papakainga. There are no completed Papakainga projects in Wairoa. However, there are at least 3 whānau/ marae in Wairoa who have registered their interests with Te Puni Kokiri. There is no doubt the process is overwhelming for most people, myself included, thus the importance to have someone in the whānau who is passionate and driven to progress this Kaupapa. Once you are at the stage of applying for the Feasibility Fund, you should seriously consider, contracting a Project Manager who has the experience and skills to ensure your project is complete.

Unfortunately, there aren't too many people working in this field. The above Papakainga were all Project Managed by the same person but at different times. It is also a thankless job with no financial gain for the person driving this Kaupapa. However the biggest reward is realising the completion of the healthy, warm, affordable homes for the whānau/mokopuna.

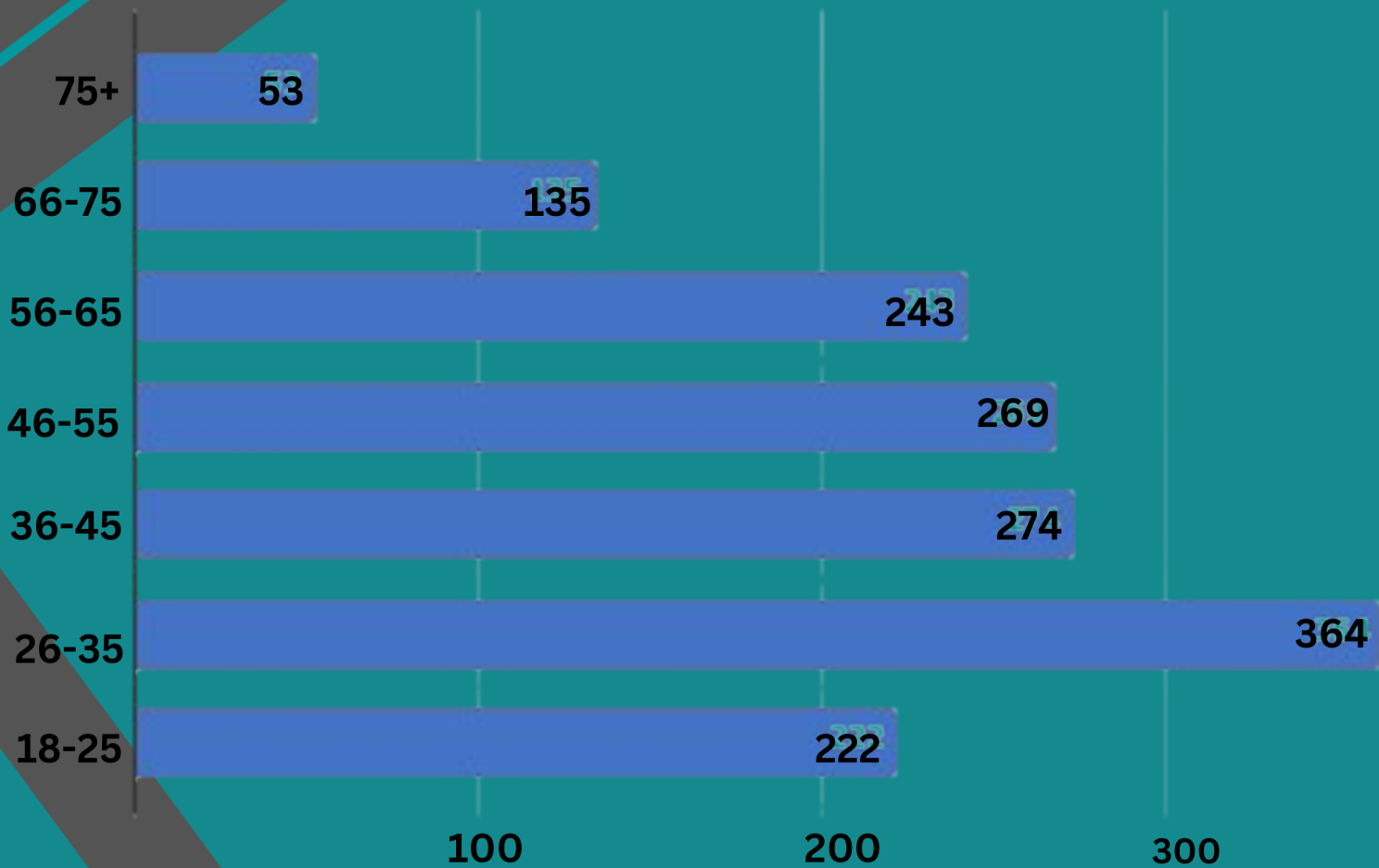

To report back on my time so far as your NTAH TToTW director - the post-match classic 'It's been a game of two halves' could sum it up - or maybe it's too close to call.



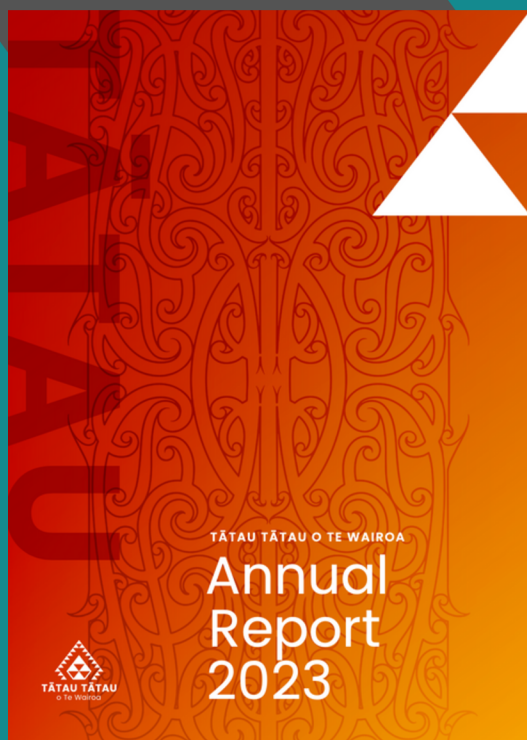

TE UREWERA PARTNERSHIP AGREEMENT

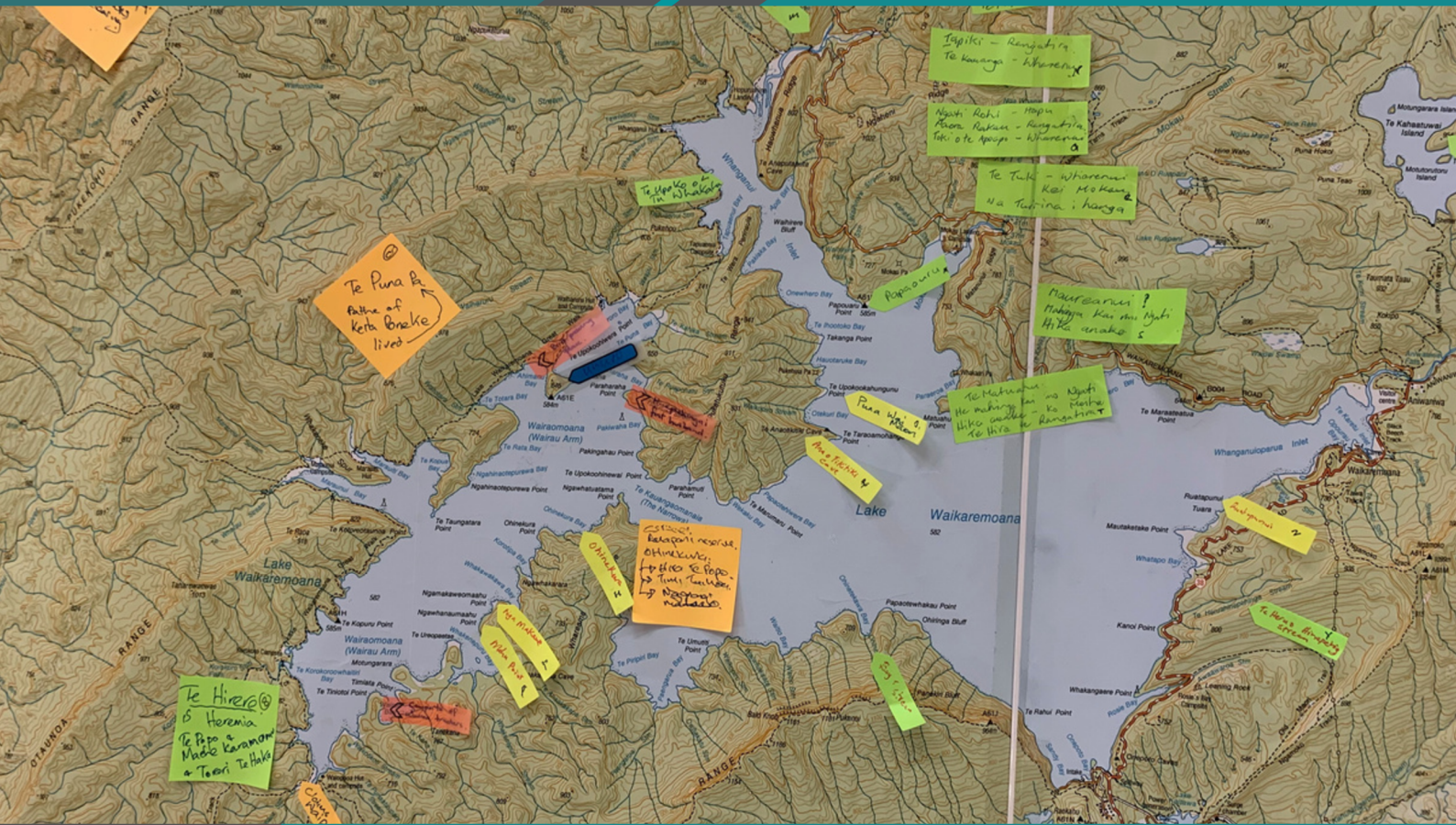


Image 2 TToTW Place Names Map, Waikaremoana, Te Kawau Maro Series, 2020

We are now into the final stages of our Te Urewera Partnership Agreement project.

Phillip Beattie (Te Wairoa Tapokorau Whanui), Katarina Kawana, Cordry Huata and myself went out on Lake Waikaremoana, Thursday June 1 2023 to capture further kōrero and images for the project.

Apiata Tapine is now collating the final report. A draft of this report will be presented back to Kāhui in the coming weeks to allow for final feedback and any additional contributions before sign-off by the trust board.

Our whanaunga Ngāti Ruapani are currently working through their treaty settlement with the Crown. The MInistry for Māori Crown Relations has requested we make known any Ian interests we have in and around Onepoto and a selection of neighbouring blocks.

HAUMAKO

Straight Outta Gizzy New GM of Haumako Robyn Kaa was formally welcomed into the TT whānau at a pōhiri, Monday 16 January 2023, at Taihoa Marae - a welcome back really given Robyn's Rongomaiwahne and Whakakī connections.

The first part of 2023 was very much about a strategic reset for Haumako involving robust discussion between both trust and commercial boards, serious negotiations with apple suppliers T&G, and tough question and answer sessions with all Kāhui.

Despite several alarming conversations overheard in the **kumara aisle at New World Wairoa** confirming the loss of squillions of dollars of settlement money - the situation was righted and lessons taken onboard.

And yes there are more apples to be planted. Haumako engaged with hapū, marae and kāhui about their plans for Whakapau Farm. The immediate priority was 10ha of Envy apples which were planted end of 2023. A further 20ha are to be planted in 2024.

Personally, Haumako is one of the more challenging kaupapa - not a hospital pass - although the issues do date back - but the knowing, that as Māori, we are all about good kai, maara kai, kai Māori, namunamuā nom nom nom. **He kai kei ā tātau ringa! We got this!**

THE FLOOD PROTECTION

Meanwhile In the background - and now mooching firmly into the foreground - is the Wairoa Flood Protection Scheme which has been another big body of work post-Cyclone on the 2022-23 calendar.

Flood protection is required to move the land categorisation from category 2A to 2C and allow repair work of damaged homes to continue. The government has ringfenced \$70M for Wairoa to undertake the flood protection work.

TToTW have been working with our Tripartite partners (Wairoa District Council, Hawke's Bay Regional Council) and the stakeholders in the Wairoa community to sign-off on the design. Options being considered are spillway, stopbanks, or a combinations of the two. The scheme will ensure our whānau, particularly North Clyde, are better protected for any future extreme weather event.

For our whānau in Pakowhai - assistance will be provided to raise the height of their homes, lifting them above the high flood level.

TAIAO UNIT

TArna Galvan was appointed manger of our TToTW Taiao Unit which is now open for business at TToTW HQ 34 Marine Parade Wairoa.

A key part of Arna's role is to develop and maintain an effective paper-flow for statutory acknowledgements in order to help our hapū with response turnaround time as the timeframes are often very very tight.





PATUNAMU FOREST

Changes to s12 Forests (s12.1 Patunamu Forest Limited) of the TT Trust Deed will happen as part of the current trust deed review which is taking place over the next 12 months. TT suggest that Kāhui begin to discuss their forest interests with each other now, with any decisions or resolutions from those discussions then being written into the s12 amendments

WAI MĀORI CLAIM

Big progress with our TToTW Wai Māori Claim in 2022-23. After consensus from our Kāhui TToTW will now support Ngāi Tahu in their court proceedings against the Crown, seeking rangatiratanga over freshwater in our takiwā.

Our lawyer Mātānuku Mahuika and his team at Kāhui Legal have successfully completed our statement of claim following wānanga and hui with affidavit witnesses and all papers have now been filed with the court.

Katarina Kawana and Hera Huata have agreed to offer kōrero in support of our case, ngā mihi ki a kōrua.

The next 12 months will involve finalising and writing-up of all evidence in preparation for a court date in 2025.

DSP MANGAPOIKE BLOCK

Despite having formally withdrawn from the Mangapoike DSP purchase back in December 2019, TToTW have made it known to NTAH that we can rejoin the Mangapoike DSP purchase process at anytime because our interest is registered in the TT oTW Trust Deed.

Manapoike Block is currently being revalued. There are three kāhui in the purchasing process: Whakakī-nui-a-rua, Tāpokorau Whānui, Tāpokorau Mai Tawhiti. Ngāi Tāmanuhiri also have an interest in this DSP and the purchase requires their agreement.

At this stage it is highly unlikely that the Mangapoike DSP will transact in 2024, meaning we will have time to discuss and wānanga this kaupapa in deciding to rejoin the purchase process.



TTOTW KAIHAUTŪ AAYDEN CLARKE

Aayden Clarke was appointed as the Kaihautū of TToTW Commercial Limited.

Aayden has whakapapa links to Ngāi Tūhoe, and Ngāi Tamaterangi :p

Born and bred in Wairoa, Aayden is a past student of St Joseph's Primary and Wairoa College.

With a foundation in Wairoa Ross Shield, first XV and Barry Cup representative, Aayden has played rugby for the Napier Pirates, Hawkes Bay Magpies and in Japan.

He has worked across management, sport, merchandise, Māori business, hospitality, trades and building.

SCHOLARSHIPS

The Trust approved a policy for scholarships in July 2023. The key points from the policy are:

TToTW Trust will annually allocate funds for scholarship grants. These grants are for study towards educational qualification, industry certification, skills credentials, or upskilling. They will be offered annually to TToTW registered members via an application process.

A selection panel must be established consisting of at least, the Chief Executive, a Trust Board member, and a kaumātua.

Michelle McIlroy was nominated by the trustees to be on the scholarship subcommittee and Hine Kohn from the kaunihera.

Applications closed in January and the committee has convened to review applicants.
